Sandia Mountain Junior Ranger Program

For the past seven years, the N. M. Friends of the Forest and U. S. Forest Service have offered the Junior Ranger Program to families who visited the Visitor Center at either the Upper Tram Terminal or Sandia Crest. This program, available to children ages 6 to 14, awards an attractive embroidered patch or a shiny, pin-on badge for completing a nature walk and a short nature quiz.

We award about 1,000 Junior Rangers each summer, and this year, even with the month-long fire danger closure of the forest, we expect to close the season with slightly below that number. A special Thank You (See Ranger continued on page 2)

Field Guide to the Sandias

After the thousands of hours that our volunteer writers, editors, fund raisers, and the many others involved in developing the Field Guide to the Sandia Mountains invested in this project, we turned it over to the University of New Mexico Press on February 26. Many issues still needed to be resolved: missing photographs, incomplete sections, more sidebars, etc., and from that point until the end of August, Bob Julyan carried the major responsibility of filling in the remaining pieces. Bob did a magnificent job in cobbling together the many parts into a wonderful and cohesive book that flows easily from one chapter to another.

We should see page proofs in another three or four weeks, and each writer will have a week to review his/her section. Then the Press will send it out for color work, printing and binding, and finished copies will be in their warehouse in March 2005. The expected selling price is \$17.95. The publication date will be in April which gives them time to get books into bookstores and reviewers' hands before the official publica-

Plans for Recreational Information Tabloid

During the spring and summer, a few NMFOF Board members and SRD staff members looked into the possibility of developing a tabloid-style paper that would carry basic information about the Sandia Ranger District, as well as listing forthcoming events and meetings scheduled by the Forest Service and the two Friends groups. Our thinking was that the basic information would remain in every issue, perhaps twice a year, and that we would tuck in a separate page listing forthcoming events. Initially we had planned to include some natural history information, but, not surprisingly, UNMPress thought it might impede sales of our Guide. We then went back to the Press with a different list of information that we would include and it was approved. We will include material on picnic areas and camping, volunteer information, a map of the Sandias and Manzanitas, fee demonstration project and pass information, wilderness restrictions, a table of monthly average temperatures and precipitation, and another of trail length and difficulty. Also included will be information about permitted and prohibited activities, winter activities, the visitor centers, biking, horseback riding, the Ranger Station, Hawkwatch, important telephone numbers, and Leave No Trace policy. We hope to get started with this new project in the next few months. (Gerry Sussman)

Kiwanis Meadow Fence Project

The major field project this year was rebuilding the buck-and-pole fence around Kiwanis Meadow. Beverly DeGruyter, Sandia Ranger District Wildlife Biologist, requested these repairs to better protect the meadow for vegetation restoration and improved wildlife habitat. On nine outings in August and September, a total of 14 volunteers participated in the project with seven of them working four or more days.

Many fence sections were in poor condition with sagging bucks (large wooden Xs) and missing or broken poles. New components cut locally in the Sandia Mountains were provided by Jonathan Boe and the SRD Fire Crew. Threaded steel rod and hundreds of long lag screws, nuts, and washers were purchased with Friends' funds. The fence crew mastered the skill of bark removal with drawknives. They peeled dozens of white fir poles and braces so that the wood will dry quickly and not hold moisture which causes decay. The crew built three new fence sections and rebuilt about 60 sections in locations ranging from Kiwanis Cabin to Kiwanis Meadow Road and the south side of the meadow. Volunteers working many long hours were Don Carnicom, Bob Moore, Sally and Bob Lowder, Dan Benton, Newton Garland, Ron Hayenga, Art Arenholz, Paul Stubbe, Anne Hickman, Bill Geck, Tim Brown, Cheryl Robison, and Sam Beard. USFS employees who contributed directly to this project were: Modesto Sanchez and Manny Chavez: electrical generator, drill, and a pickup, and Phyllis Martinez: drawknives and other tools. Sandia Crest Scenic Byway Sign Repair and Painting

The large 5-foot by 25-foot Scenic Byway sign at the Triangle at the intersection of NM-14 and NM-536 was designed and constructed in 1991 by Ross Ward, the Tinkertown artist and craftsman. The most outstanding features of the sign are the big horn sheep and buffalo images cut in a steel plate which has a natural iron oxide patina. After the Friends noticed the weathered and sun-damaged wooden surfaces, Don Carnicom checked with the N. M. Department of Transportation, the Sandia Ranger District, the builder's widow, and the Turquoise Trail Association; but no one claimed ownership or responsibility for this attractive landmark.

The Friends unofficially adopted the sign, and on April 21 twelve volunteers rebuilt the two lumber joints. Large nails were replaced with lag screws which pulled the warped boards into alignment. The volunteers then painted the red background and large cream countersunk letters. Two volunteers returned on May 5 to paint the turquoise letters. An article and photograph of the project work appeared in an East Mountain newspaper. Volunteers working on the project were Hoyt Beard, Sam Beard, Bob Moore, Dan Benton, Tim Brown, Bob Lowder, Bill Metz, Stan Upchurch, Dick Baumann, Lynn Bender, Don Carnincom, and Newton Garland. tion date. As we have said before, and it bears repeating, this has been a labor of love for all of us, and it will be our gift to all those who take great enjoyment from the Sandias. The Field Guide will forever be a source of pride for the volunteers and Forest Service. (Gerry Sussman)

Maintenance of Wildlife Drinkers in Manzanita Mountains

A few dozen wildlife watering devices (known as "drinkers" or just "waters") are located throughout the Sandia Ranger District. Some designs of drinkers are: concrete troughs in canyon bottoms (Embudito Canyon mouth), pipes from a spring to a trough (Media Spring), large-surface-area rubber or metal collectors with a tank and float valve, and large galvanized steel culvert-like tanks with sloping collection panels on top. Maintenance requirements include repairing tears in the rubber linings or holes in a metal tank, repairing float valves, replacing hose or pipes, and removing gravel from troughs.

On April 14, Beverly DeGruyter, SRD Wildlife Biologist, Daniel Harbour, Sandia National Laboratories Security Force, and volunteer Sam Beard inspected drinkers at four locations on the western slopes of the Manzanita Mountains immediately east of Kirtland Air Force Base. On July 28, Beverly, Sam, and volunteers Dan Benton and Bob Moore performed maintenance on five drinkers east of KAFB. At the three drinkers in Sol Se Mete Canyon, the work included installing bolts and nuts securing the steel collectors, installing two wooden runoff deflectors to reduce silt collection, pruning a juniper to reduce deposition of needles in a tank, replacing a 2-ft by 12-ft metal panel, cleaning a collector screen, removing wood and metal from an old collector, and delivering a roll of black plastic pipe.

On May 18 Beverly, Sam, and Mary Voldahl, USFS, checked waters at three locations in David Canyon south of the Ranger Station and west of NM-337. Repairs will be made at these drinkers when patching material has been obtained. (Sam Beard)

News Items

- * Sandia Ranger District and Friends' member, Stan Upchurch, has moved to Colorado Springs. Stan was a very active volunteer on the SRD, in the City Open Space, and at local races. He participated in several NMFOF projects over the past three years and was especially interested in graffiti removal and trash collection. He is best known for the restoration of several stone and concrete restrooms built during the Depression in the Juan Tabo and La Cueva Picnic Areas. We will miss Stan and wish him well in Colorado.
- * In October 2003, Don Carnicom installed professionally fabricated map panels purchased with NMFOF funds at the Doc Long, Sulphur Canyon, and Cienega Picnic Areas and at the Cienega Horse Bypass Trailhead. Phyllis Martinez, trails leader at the Sandia Ranger District, created all of the maps.
- * The NMFOF Board agreed to support the Tijeras Canyon Safe Passage Coalition (TCSPC) being organized by Jan Hayes. The group is working for the construction of a wildlife passage over or under I-40 and NM-333. The structure would reduce the number of vehicle-animal collisions which injure or kill humans as well as wildlife.

Spruce-Up Crew Activities

- * Upper Balsam Glade Restroom, October 2003 Sam Beard scraped and painted the exterior walls which were in bad condition with much of the paint being cracked or missing.
- * The large gray portal signs with roofs at the following trailheads were painted or repaired by the volunteers listed: Lower La Luz Trailhead—Stan Upchurch: 3-Gun Canyon Trailhead—Don Peterson and Sam Beard: and Tunnel Spring, Mars Court, and Tunnel Canyon—Sam Beard.

Cienega Nature Trail Renovation

The Cienega Nature Trail is one of only two wheelchair-accessible trails in the Sandia Mountains. It is located in the central part of the Cienega Picnic Area near the group picnic tables. All of the aluminum Braille interpretive sign panels have been damaged or removed. On July 13, seven members of the Wind Walkers (an East Mountain hiking group), five USFS volunteers, and five Friends worked seven hours cutting grass and weeds, painting wood structures, repairing hand rails and barrier fences, and installing new "Wheelchair-Accessible" signs. Tecolote Trail Maintenance

A great team of people showed up on the morning of August 14 to help whip Tecolote Trail into shape. Friends of the Forest members, Forest Service Volunteers. Adopt-A-Trail (AAT) members, and USFS managers Mary Bean, Dana Howlett, and Rick Atwell joined to clean water bars, trim brush, and paint the Friends' AAT sign. A picnic lunch, following the work, was enjoyed by all. Thanks to all the people for taking time out of their busy schedules to spruce up a heavily used trail. The wildflowers were great, too. Embudito Canyon Barbed Wire Fence Removal Project

The barbed wire fence removal project in Embudito Canyon begun in FY2003 was continued this year. This fence was on the south boundary of the Elena Gallegos Land Grant. The fence immediately east of Glenwood Hills and some of the fence near the trail being rerouted by Phyllis Martinez. USFS, were removed in FY2003. On October 4 and 11, volunteers completed removing the wire from the posts and rolling it into bundles. Most of the bundles were carried to the trailhead as the volunteers hiked out. Volunteers working on this project in FY2004 were Charles Wood, Sam Beard, Marion Simon, Andy Simon, Newton Garland, Dan Benton, and Merrill Callaway. During the summer of 2004, Stan Upchurch and Sam Beard carried out the remaining seven rolls of wire. The steel posts are firmly set in the very rocky mountain side, and no efficient method of removal has been found. (Sam Beard)

Emergency Trail Maintenance Crew Activities

This volunteer crew removes fallen trees from hiking and cross country ski trails during all seasons of the year. Don Carnicom, Bill Geck, and Ron Hayenga usually go out about once each week to cut trees, install signs, or do other work in the field. They are sometimes joined by Phyllis Martinez, Chris Michel, Sam Beard, Newton Garland or the Lowders and welcome others who would like a day in the outdoors.

^{*} Following a late winter storm with heavy wet snow which broke dozens of tree branches around the Ranger Station, several Friends cut hanging damaged branches and collected broken limbs and placed them in piles for chipping later.

Treasurer's Report
